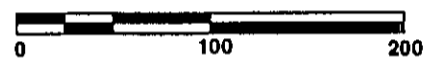
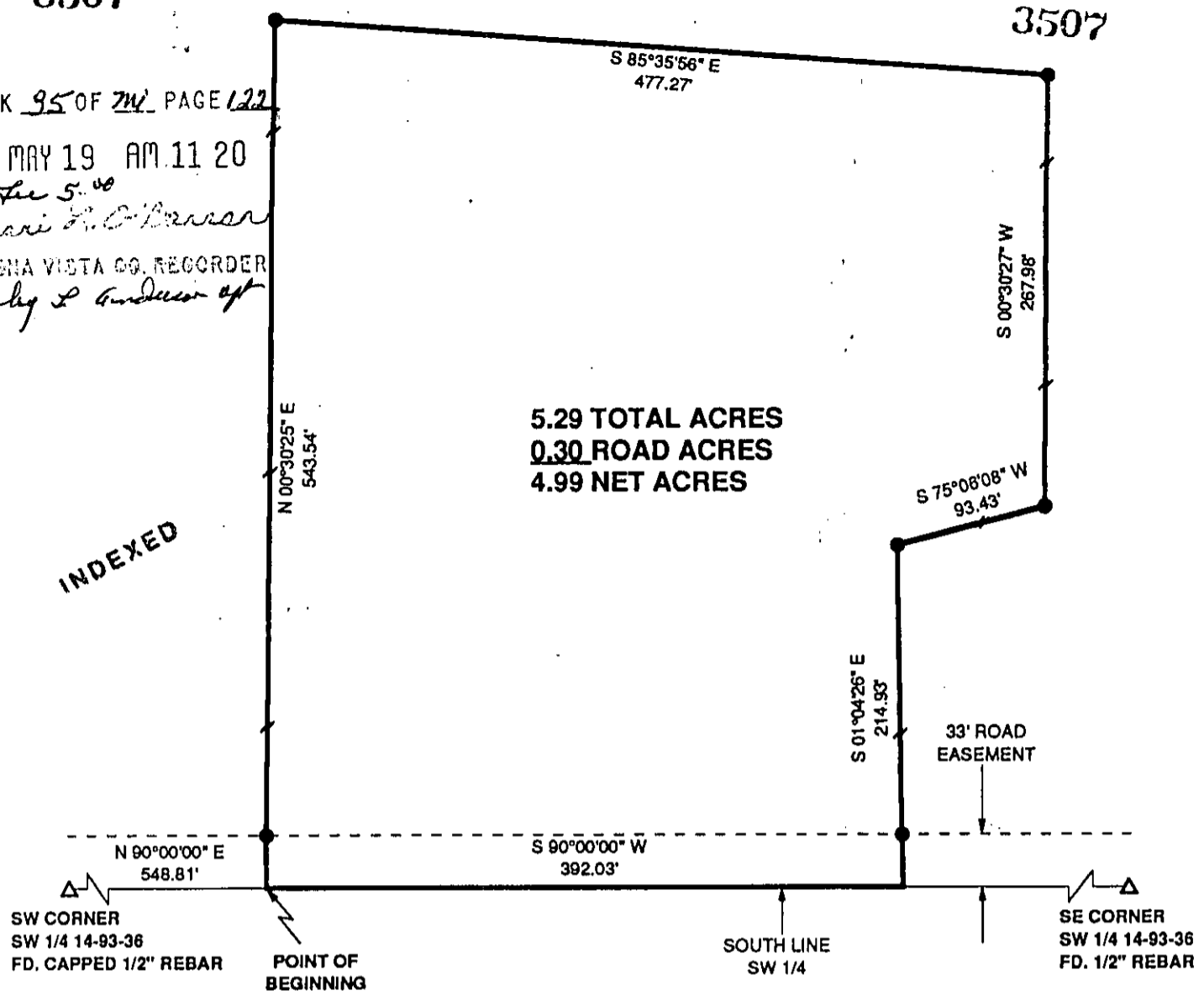

Thence North 00° 30' 25" East, 543.54 feet; Thence South 85° 35' 56" East, 477.27 feet; Thence South 00° 30' 27" West, 267.98 feet; Thence South 75° 06' 08" West, 93.43 feet; Thence South 01° 04' 26" East, 214.93 feet to the South line of said Southwest Quarter (SW 1/4); Thence South 90° 00' 00" West along said South line, 392.03 feet to the Point of Beginning.
