DESCRIPTION OF PARCEL E:
Commencing at the Northwest Corner of Section 6, Township 96 North, Range 41 West of the Fifth Commencing at the Northwest Corner of Section 6, Township 96 North, Range 41 West of the Fifth Principal Meridian, O'Brien County, lowa, as the POINT OF BEGINNING; thence South 89 degrees 47 minutes 10 seconds East along the North line of the Fractional Northwest Quarter of said Section 6, a distance of 353.02 feet; thence South 00 degrees 03 minutes 05 seconds West a distance of 896.95 feet; thence North 89 degrees 56 minutes 48 seconds West a distance of 353.05 feet to the West 100 seconds Fast along line of said Fractional Northwest Quarter; thence North 00 degrees 03 minutes 12 seconds East along said West line, a distance of 897.94 feet to the POINT OF BEGINNING. Parcel E contains 7.27 acres inclusive of 1.26 acres of easement for county roads along the North and West sides thereof.

DESCRIPTION OF PARCEL F:

Commencing at the West Quarter Corner of Section 6, Township 96 North, Range 41 West of the Fifth Commencing at the West Quarter Corner of Section 6, Township 96 North, Kange 41 West of the Fifth Principal Meridian, O'Brien County, Iowa, as the POINT OF BEGINNING; thence North 00 degrees 03 minutes 12 seconds East along the West line of the Fractional Northwest Quarter of said Section 6, a distance of 1,018.43 feet; thence South 89 degrees 56 minutes 48 seconds East a distance of 353.07 feet; thence South 00 degrees 03 minutes 05 seconds West a distance of 1,019.74 feet to the South line of said Fractional Northwest Quarter; thence North 89 degrees 44 minutes 03 seconds West along said South line, a distance of 353.11 feet to the POINT OF BEGINNING. Parcel F contains 8.26 acres inclusive of 1.17 acres of easement for county road along the West side thereof.

Commencing at the Northwest Corner of Section 6, Township 96 North, Range 41 West of the Fifth Commencing at the Northwest Corner of Section 6, Township 96 North, Range 41 West of the Fifth Principal Meridian, O'Brien County, lowa; thence South 89 degrees 47 minutes 10 seconds East along the North line of the Fractional Northwest Quarter of said Section 6, a distance of 353.02 feet to the POINT OF BEGINNING; thence South 00 degrees 03 minutes 05 seconds West a distance of 896.95 feet; thence South 89 degrees 58 minutes 48 seconds East a distance of 306.95 feet; thence South 00 degrees 03 minutes 12 seconds West a distance of 747.05 feet; thence North 89 degrees 56 minutes 48 seconds West a distance of 306.93 feet; thence South 00 degrees 03 minutes 05 seconds West a distance of 1,019.74 feet to the South line of said Fractional Northwest Quarter; thence South 89 degrees 44 minutes 03 seconds East along said South line, a distance of 817.54 feet; thence North 100 degrees 03 minutes 05 seconds East a distance of 2,664.48 feet to the North line of said Fractional Northwest Quarter; thence North 89 degrees 47 minutes 10 seconds West along said North line, a distance of 817.54 feet to the POINT OF BEGINNING. Parcel G contains 44.74 acres inclusive of 0.62 acre of easement for county road along the North side thereof. 0.62 acre of easement for county road along the North side thereof.
